- The September minutes and financial reports were presented. Doug Beland made a motion, seconded by Pat Hasenbank to approve. Motion carried.

Unfinished/Old Business

- After attending a Webinar on Directors and Officers Insurance, Chair Pam Spear and Jon Bell agreed a policy is needed for CCEDCO Board members. The Office Manager will have quotes for the next meeting. Jon Bell added maybe the County insurance carrier would cover CCEDCO accepting them as part of their group. New Business

- The New Executive Director talked about what he would like to bring to CCEDCO. His thoughts are to build on existing businesses strengths and assist them in them getting help where needed so they can achieve their goals. There are many challenges for small businesses that have been in place for some time. He believes in slow and sure progress with creativity being incremental to success. He would also like to see the Office Manager get more involved.
- The Executive Director and Office Manager will be working on a "Shop Local" campaign for Cedar County to coincide with "Small Business Saturday" on November 29th. He is confident if the community can grow from people that business growth will follow. In today's world, you can start and run a business from almost anywhere. If we can create a place people want to be, they will come. Economic growth starts with seeing yourself in a way you have never seen yourself before. Adam Sandberg agreed saying making small town life attractive to city dwellers is important. The Executive Director also added in the near future he would like to host a conference to get city leaders to start thinking of what the next generation wants and to make downtowns more appealing to attract people.
